## The 10-year warranty

**On the basis of the results of laboratory quality tests, the Profile VOX Ltd. (hereinafter referred to as: The Producer) hereby grants the 10-year warranty for the system of external cellular cladding panels Kerrafront FS-201 / FS-202 and the system of PZ607 profiles (hereinafter referred to as: The Products).**

The Producer hereby guarantees that in the Warranty Period the Products shall maintain their physical and mechanical properties, i.e. they shall not crack, peel, swell, corrode, and shall maintain their impermeability and resistance to frost during normal use. Moreover, the Producer declares that The Products are manufactured with use of 100 per cent lead-free stabilizers. As for the colour fastness of The Products as exposed to UV radiation in climatic conditions of moderate climate zone, with air temperatures not exceeding 40°C at elevations up to 1800 metres above sea level, the Producer informs that the changes can have uniform character, and they should not exceed the 3rd grade of the grey scale per every 100 kLy of insolation (as defined in the EN 20105-A02 Standard).

This Warranty covers locations in climatic conditions as stated above and is valid for ten years from the date of purchase, provided that The Producer shall have been notified in writing of finding the faults within 1 month of their finding, and not more than 12 years from the date of manufacturing. Presenting the proof of purchase is a prerequisite for the investigation of the complaint.

This Warranty does not cover faults resulting from using The Products for other purposes than originally intended, improper storage conditions, or site assembly not in conformity with assembly instructions as published on the Producer's website. Moreover the warranty does not cover faults resulting from using accessories or substances not recommended

in the Producer's assembly instructions, impact of foreign objects, cracking or subsiding of walls, fire, earthquake, lightning discharge, hurricane, hailstorm, acts of vandalism, extremely low or high air temperatures, or other events that may be classified as Force Majeure.

On the grounds of site inspection and examination performed by the Producer's representatives, each element that shall have been found as not conforming to the quality requirements, shall be repaired or replaced with the fault-free element, or a money compensation shall be paid for faulty Products and the cost of replacement thereof, subject to the Producer's discretion. The Producer's share in the costs resulting from fulfilling liabilities as resulting from this warranty document shall be in direct proportion of the number of unexpired months of the warranty period - to the number of months of the whole warranty period. For the purposes of calculating the number of the unexpired warranty months the date of purchase and the date of making the claim shall be taken into account.

For the avoidance of doubt, the Producer points out that this Warranty excludes their liability for costs of any work in case of faults that are visible prior to the assembly. In no event shall the Producer be liable for any loss or damage resulting from the Products' faults, whether direct, indirect, special or consequential, other than in the scope indicated above.

Due to constant commitment of the Producer in the process of quality improvement and development of the Products, in case the Product is replaced pursuant to this Warranty, in a situation whereas the manufacturing of the products as assembled by the Buyer is discontinued, or the products will have been modified, The Producer reserves the right to use elements as they deem most equivalent to originally used Products.
